- 1. Have registered a live trading account with Thaurus by providing the necessary identification documentation.
- 2. Are eligible to trade as per Thaurus's onboarding Client Agreements.
- 3. Have agreed to these Terms.

PROMOTION RULES

- 1. The Promotion credit is non-withdrawable.
- 2. The Promotion may be combined with any other credit or cashback received on trading volume that Thaurus may offer from time to time. Cumulative credit granted shall not exceed USD 2,000.
- 3. The Promotion is available on a per-client basis (not on a per-account basis), regardless of the number of accounts held with Thaurus.
- 4. Transfer of funds between trading accounts is always available via internal transfer.
